

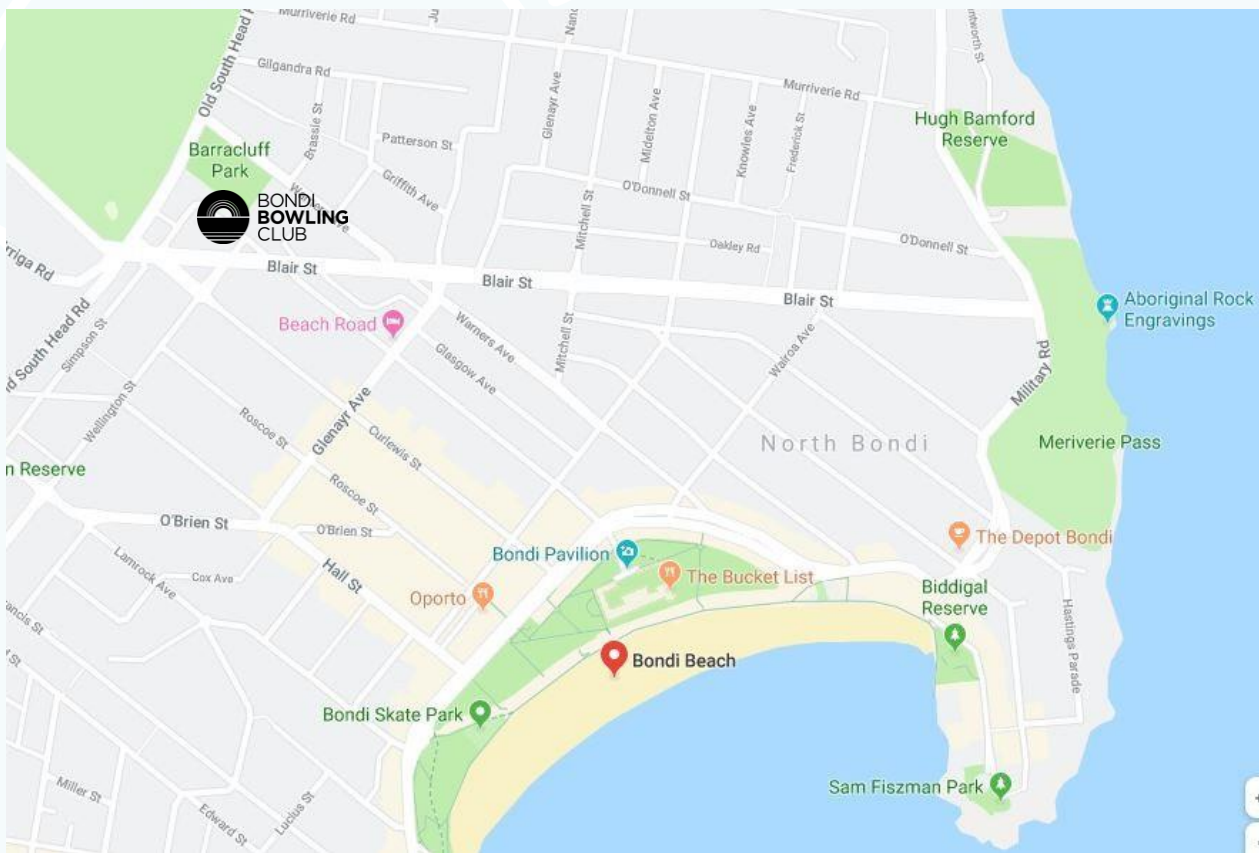

IMPORTANT INFORMATION

As a bowling club, all guests are required to sign in on arrival. Guests living within a 5km radius of the club will need to be signed up, or signed in by any existing member. Guests from outside the 5km radius can sign in directly as a temporary guest. Social membership will also be available (\$10) to guests.

The Club is conveniently located just a block from to two main bus routes (387, 389) that go direct to Bondi Junction station.

COVID-19

All guests must adhere to COVID Safe Practices while visiting the venue:

- Signing in on arrival
- Social Distancing of 1.5 metres between guests
- Washing and Sanitising hands regularly throughout visit
- Vacating area immediately at the end of booking, unless space is available
- Always be seated where possible

The person booking the event agrees to be the primary contact in the event of any contact tracing required, and you will be responsible for knowing the contact details of all attendees in your group

BOOKINGS

Bookings are limited to 2 to 10 guests per booking of Bowls and 2 – 400+ for events.

Pre-Bookings are required for all groups and corporate functions.

A payment is required to confirm any group booking. This can be in the form of a table deposit, a rink payment, or a food and/or drink payment.

BAREFOOT BOWLS

Cost per rink is

EVENT TERMS & CONDITIONS

Confirmation & Payment

Bookings are confirmed upon receipt of these 'Terms & Conditions' and the requested deposit.

All catering orders must be paid in full, and guest numbers provided at least 5 days prior to the function.

Bar tab / drinks packages and any additional catering must be paid before the start of your event by either credit card or cash.

Cancellation and Refunds

Cancellations made up to 4 weeks before an event will have payments reimbursed, less any costs incurred.

Cancellations made with 1 & 3 weeks' notice, will have retain 50% of the room and rink hire retained. Cancellations with less than 7 days' notice, will have 100% of the room and rink hire and catering payments retained.

If there is wet weather on the day of the event and the greens are unplayable, rink hire fees may be converted to food/drink tab, to be consumed on the event date, or for rink hire at a future date. There will be NO refund of food/catering payments or indoor room-hire due to wet weather on the day of an event.

Drinks packages

Where there has been a pre-committed bar-tab/drinks package – and the value of that package has not been fully consumed on the date, a refund will not be given. However, under certain conditions, the cost may be redeemable. If more than 48 hours' notice is given to cancel drinks packages, the amount will be redeemable. With less than 48 hours' notice or if there are less people in attendance on the day, the cost will not be redeemable or refunded. Only individual drink can be ordered at the bar.

Duration of function

Functions are booked for a standard duration of 3 hours unless otherwise specified, guests may need to vacate within thirty minutes of the finishing time, if there is a later booking. In accordance with licensing guidelines, all bar service will cease at the function completion time prior to the function completion time. For evening functions, last drinks will be called by 11:00pm.

Sign in Rules

The sign in rules for all NSW clubs apply to the Bondi Bowling Club. If you are a member of the club you may sign in your guests who are not members but live inside the 5km range.

Guests living outside the 5km range may sign in as a guest of the club. For some events, the Bondi Bowling Club may organise a specific event sign-in register in cooperation with the organiser, to help expedite the sign in process.

Food and Beverage

No food or beverage is permitted to be brought onto the club's premises at any time (except celebration cakes e.g. birthday, etc).

Due to hygiene reasons, please bring your own paper or plastic plates and disposable cutlery to serve your cake/s with. Prior arrangements for celebration cakes must be made with the Club's Function Manager.

Children & Minors

As a Registered Club, the regulations and laws of the Office of Liquor Gaming and Racing (OLGR) and the Registered Clubs Act are applicable to all parents and guardians of children and minors while at the Bondi Bowling Club. A Minor is defined by law as any person under the age of 18 years of age. This includes babies and infants.

Minors must be under adult supervision at all times.

Minors are not permitted in the bar area at any time and not within 1.5 metres of the bar in the dining area.

Minors must be accompanied by an adult when using the bathrooms.

Minors are not permitted on any greens unattended.

Minors must not run around, jump or shout while inside or outside the clubhouse and should remain with parents/guardians at all times.

Minors are requested to leave the premises by 7pm if attending a function.

Responsible Service of alcohol

Bondi Bowling Club is committed to the responsible service of alcohol in addition to all other relevant legislation. Hosting and/or paying for a function does not exempt any patron from these requirements.

Security

Some Functions will incur a fee for the hiring of Security. Fee is \$42 per hour per guard - minimum 4 hours payable to the Club, which will be determined by the manager. Higher rates for Security will apply during public holidays.

18th & 21st Birthday Parties

Any 18th or 21st Birthday Parties will be considered for approval only after consultation with Management and Directors and if there is an acceptable ratio of older adults to provide adequate supervision. The organiser is required to cover the charge of an additional Security Guard at the rate of \$200 or Public Holiday rate is \$250. Security must be paid for seven (7) days in advance.

EVENT TERMS & CONDITIONS

Conduct of patrons / Damage & Insurance

For the duration of your function you & your guests must agree to act in an orderly manner and abide by our venue regulations. You will be held financially responsible for any damage caused by you or your guests to the premises or our property during a function. The Bondi Bowling Club may request a bond payment for certain events.

The Bondi Bowling Club reserves the right to exclude or eject any or all of the guests attending an event at its sole discretion, without liability. Behaviour from guests that is improper will not be tolerated. The Bondi Bowling Club will try to take all reasonable care, but will not accept responsibility for damage to or loss of items before, during or after a function.

No responsibility will be taken for gifts or decorations brought onto the premises. All minors attending functions are required to leave by 7pm.

All patrons including children must wear shoes and be appropriately attired at all times. We are in a residential area so please be considerate when leaving the premises and keep any noise to a minimum.

Special dietary requirements

Our kitchen will take care in preparing menu items, however some food products may contain allergens that individual guests may be allergic to, and the club will not be responsible for illness that may result.

Decorations

All decorations must be removed by the client on the conclusion of the function or at a time that has been agreed with the club. Decorations must be approved by the club prior to the event.

Clients will be financially liable for any damage sustained to the Club or its property. The cost for repairs or replacement to any damage that occurs will be passed on to the client.

Entertainment

The Club will allow for functions to book entertainment upon approval. The event organiser can organise pre-approved DJs, live acts, and trivia hosts for your event upon request if the event has been deemed suitable. If the client wishes to book entertainment themselves then the details of the act will need to be provided to the event organiser prior to the booking for approval. The event organiser will then provide the client with the equipment requirements for the entertainment. All entertainment cost are to be covered by the client.
